



INITIAL GRANTEES NAMED FOR STATEWIDE INITIATIVE—COMMUNITY ECONOMIC RESILIENCE FUND—IN ORANGE COUNTY

The one-year planning grant supports the creation of a High Road Transition Collaborative, research efforts, and county-wide engagement

IRVINE, CA (June 30, 2023)—<u>Orange County Business Council</u> (OCBC) and <u>Charitable Ventures</u> today announced the 27 Orange County-based organizations as initial grantees for Phase I funding from the <u>Community Economic Resilience Fund</u> (CERF), a statewide initiative created to promote a sustainable and equitable recovery from the economic distress of COVID-19. OCBC serves as the regional convener and Charitable Ventures serves as the fiscal agent.

Orange County is one of only 13 regions statewide to be part of the CERF initiative designed to diversify local economies and to develop sustainable industries that create high-quality, broadly accessible jobs for all Californians.

In Phase I, a multi-sector group called the High Road Transition Collaborative (HRTC) will map regional strengths and opportunities to design a new economic development plan for Orange County. The collaborative represents labor, business, community, philanthropy, government, education, workforce development and other sectors.

"This is an important opportunity for our region to build a healthier economy as we have emerged from the pandemic," said Jeffrey Ball, President and CEO of Orange County Business Council. "We are proud to be the regional convener for Orange County and this diverse group of partners working with us. Together, we are taking a high-road approach to economic development that supports the creation of good-paying, quality jobs, while centering community and worker voices in the planning process."

The High Road Transition Collaborative has awarded a total of nearly \$900,000 to 27 Orange County-based organizations for outreach and engagement purposes. Over the next couple of months, grantees will conduct outreach with residents, businesses, and other stakeholders, with a focus on disinvested community members. Feedback collected, including information about community assets and needs, race and systemic barriers that have prevented individuals from accessing economic opportunities, and an assessment of local health and environmental equity, will inform and influence Orange County's new economic development plan.
